## NONPARTY'S EMERGENCY MOTION TO STAY THE ORDER TO GODADDY / SUCURI AND TO RESCHEDULE THE ZOOM HEARING

Nonparty, BEN OREN ("OREN"), respectfully files this EMERGENCY motion to reschedule the Zoom hearing and to stay the order to GoDaddy / Sucuri.

- 1. On August 16<sup>th</sup> I was surprised to receive an order in my email stating that the my motion to quash the subpoena in question was denied due to lack of appearing to the hearing.
- 2. I did not know that there was a hearing in this case, because the plaintiff issued AN EXACT SUBPOENA in another case that he is managing at the same time against the same "defendants". The additional case number is 2022-045761-SP-25.
- 3. On September 6, 2023, there will be a Zoom hearing on the motion to quash that I filed in case 2022-045761-SP-25, regarding the exact same subpoena that the plaintiff issued in this case. The copy of the summons for the Zoom hearing of case 2022-045761-SP-25 is attached as exhibit A. The copy of the subpoena to which the Zoom hearing in case 2022-045761-SP-25 will refer is attached as Exhibit B.
- 4. On August 17, I called the office of the Honorable Judge's legal assistant, informed her of the manipulation done by the plaintiff and asked to reschedule the hearing. Obviously, there cannot be any legitimate justification to argue the same issue

in two separate cases. It is also clear that the plaintiff's only goal is to <u>make sure that no</u> one shows up for the hearings except him.

5. This plaintiff abuses the Florida legal system: In case 2022-045761-SP-25 he continues to identify himself as "Abi Roy Dubitzky", even though legally it is not his name since 2015 and even though in case 2018-004436-SP-26 an Order of Dismissal was issued that prohibits him from using the name Abi Roy Dubitzky (Attached as Exhibit C). In this case his name appears as "Roy Miller".

## 6. <u>All the plaintiff's motions in all his cases are always granted without any factual investigation and due misleading honorable judge.</u>

- 7. According to the subpoena in question, GoDaddy is required to produce <u>Oren's personal information</u>, which constitutes a serious violation of his right to privacy, for the benefit of a person he does not know and as a part of a case which Oren does not and has had no acquaintance with any of it's parties.
- 8. Oren opposes the subpoena in question and the demand compelling Sucuri/GoDaddy to provide any personal information of himself and his clients none of whom are among the parties to this case regarding the account to which the adubi.io domain belonged.
- 9. This motion to stay the order is essential: producing all the data required from the subpoena in question, regarding Oren's account, causes a serious and unjustified violation of the right to privacy of Oren and his customers: **Communications between non-parties** (as requested) **are protected by the right to privacy in Florida**. **The right to privacy is a fundamental right that is protected by the Florida Constitution** (Article I, Section 23). The right to privacy protects individuals from unreasonable searches and seizures, and it also protects individuals from having their personal information disclosed without their consent.
- 10. <u>Financial information requested, including billing details etc.</u>, is also protected by the right to privacy in the Florida Constitution.

11. Names of customers; email addresses of third parties who are non-

parties to the case; their phone numbers; IP addresses and correspondence with

them are all protected and confidential data. Transferring this information to plaintiff

will cause a serious violation of the right to privacy of Oren and his customers and will not

serve any legitimate interest of plaintiff.

12. The right to privacy also protects the requested data regarding any

correspondence between Oren and third parties who are non-parties to this case and

Sucuri / GoDaddy regarding the start and stop of the service and the dates when these

events occurred.

13. Fraud of the court in itself justifies the annulment of the order. If the

honorable judge will decide to stay the order, the unjustified violation of rights will already

be caused and it will be caused entirely to third parties to this case.

14. If so, there are countless legal grounds for quashing the subpoena, such as

lack of relevance and privilege. Since the subpoena demands personal information of

Oren, who is a third party, it's clearly violating Oren's privacy rights.

15. Wherefore, I will respectfully ask the honorable court to grant my emergency

motion to stay the subpoena to GoDaddy/Sucuri. I will also request to reschedule a new

Zoom hearing, considering the complex circumstances of this case, the plaintiff's abuse

of the legal system, as well as the fact that I am a citizen of a foreign country who is not

represented by an attorney.

## ORDER VACATING ORDER STRIKING PLEADINGS AND ORDER OF DISMISSAL

THIS CAUSE came before the Court for routine case management review on February 12, 2019. The Court is also in receipt of Plaintiff's Motion for Entry of Final Judgment filed February 6, 2019. The Court having reviewed the pleadings, orders, documents filed by the parties, and being otherwise apprised in the premises, hereby enters the following ruling.

WHEREFORE, IT IS ORDERED and ADJUDGED that the Order Striking Pleadings rendered February 5, 2019 is hereby SET ASIDE and VACATED in all respects, as having been entered in error.

IT IS FURTHER ORDERED that this matter is DISMISSED with prejudice.

Respectfully, the Court finds that Plaintiff, Abi Roy Dubitzky does not have legal standing to bring this cause of action, as he legally changed his name to Roy Miller on February 4, 2015 (See attached Ex. "A" – Final Judgment of Change of Name rendered February 4, 2015). Roy Miller is the only individual that has legal standing to maintain this cause of action for alleged defamation.

Moreover, the specific allegations contained in the Statement of Claim filed on May 2, 2018 by Plaintiff, Dubitzky related to alleged defamatory acts by Defendant, Lazmi, all of which occurred at times after the above referenced name change of Plaintiff to Roy Miller.
